Public Works

May 20-26 is National Public Works Week! We'd like to thank our Public Works Dept for always doing a great job keeping our Castle Hills community safe and beautiful.

This month in Public Works we are focusing on water conservation:

Stage 2 Water Management was initiated in response to extreme heat and drought conditions. Stage 2 Water Management will remain in effect until further notice. All water customers must adhere to Stage 2

Requirements:

- No outdoor water use between 10:00 a.m. and 6:00 p.m.;
- Customers with odd-numbered addresses (1, 3, 5, 7, 9) are to irrigate on Tuesdays and Saturdays;
- Customers with even-numbered addresses (0, 2, 4, 6, 8) are to irrigate on Thursdays, and Sundays;
- No outdoor watering on Mondays, Wednesdays or Fridays.

Water Management Tips

	Water Savings	Cost
• Install a faucet aerator on your kitchen sink	10 - 20 gal/day	\$ 5.50
• Cook Smart. Peel and clean vegetables in a bowl of water instead of under running water		N/A
• Install a faucet aerator on your bathroom sink	5 - 10 gal/person/day	\$ 3.60
• Turn off the faucet when you brush your teeth	5 - 10 gal/person/day	\$ 0.00
• Do not use toilets as a trash can	3 - 7 gallons/flush	\$ 0.00

Look for Leaks

- Read your water meter before and after a two-hour period, when no water is used. If it doesn't read exactly the same, you have a leak. N/A
- Add 12 drops of food coloring to your toilet tank and wait an hour. Look to see if any color seeped through the tank, a fitting, or into the toilet bowl. If so, you may have a leak
- Use a grease pencil to mark the water level of your pool at the skimmer. Check the mark 24 hours later to see if you have a leak. N/A

Maintain your Irrigation System

Check your irrigation system controller and reduce the number of days, reduce the time each zone is running or turn the system off and manually operate your irrigation system only when needed. Utility Billing

District 1-A has implemented a Residential Disabled Carry-out Service designed to assist temporarily or permanently disabled persons in taking their trash and/or recycling to the curb or alley for collection. For more information and an application, please visit our website at www.dentoncountyfwsd.com.

Denton County Fresh Water Supply District 1-A's solid waste franchise agreement permits "carry-out" service, at the normal residential rate, for residents who are temporarily or permanently disabled and unable to take their trash and/or recycling to the curb or alley for collection. In order to be eligible for this service, the following criteria must be met:

1. No one else living in the household or employed by the resident is capable of carrying the trash and/or recycling to the curb or alley;
2. A physician must certify that the resident's disability is of a nature that it prevents the resident from carrying the trash and/or recycling to the curb or alley; and
3. Unless the disability is of a permanent nature, applications for carry-out service must be resubmitted annually from the date of the original application until the disability no longer exists. Failure to do so will result in discontinuance of residential disabled carry-out service.
