

## NOTICE OF DIRECTORS ELECTION

Notice is hereby given that Denton County Fresh Water Supply District No. 1-F (the "District" or "DCFWS District No. 1-F") will hold an election on May 5, 2018, between the hours of 7:00 a.m. and 7:00 p.m., at the Castle Hills Community Center, 2501 Queen Margaret Drive, Lewisville, Texas 75056 for the purpose of electing three (3) directors, each of whom shall serve a four (4) year term. Only qualified resident electors of DCFWS District No. 1-F will be allowed to vote in such election.

The election is being held pursuant to an Order Calling Directors Election adopted by the Board of Directors of the District on January 17, 2018. Said Order is on file in the office of Winstead PC, attorneys for the District, at 2728 N. Harwood Street, Suite 500, Dallas, Texas 75201, where any interested person may refer to it for all purposes.

The Board of Directors of the District has entered into a Joint Election Agreement and Contract for Election Services ("Agreement") with Denton County for the administration of the May 5, 2018 election. Pursuant to such Agreement, said election will be administered by Frank Phillips, Denton County Elections Administrator.

Early voting by personal appearance shall be conducted on the dates, at the times set forth and at the early voting locations designated by the Denton County Elections Administrator and, as set forth in Exhibit "A" hereto and made a part hereof or as such may be amended through the terms of the Agreement. The early voting clerk's mailing address to which ballot applications and ballots to be voted by mail may be sent is DCFWS District No. 1-F, c/o P. O. Box 1720, Denton, Texas 76202, Attention: Denton County Elections Administrator.
