STAGE 1 WATER MANAGEMENT IN EFFECT

On October 3, 2011, the District changed from Water Management Stage 2, which involves mandatory restrictions back to Stage 1 Water Management, which is voluntary. While the outdoor water restrictions have been relaxed, all customers are encouraged to continue to conserve water. The ability for the District to provide a dependable water source for fire protection and customer use is one of our highest priorities. The wasteful use of water strains the District's water system and makes it difficult to allow voluntary watering use. There have been many articles and news stories regarding the potential for North Texas to be in a drought period that will last several years. Our main water sources, Lake Lewisville and Lake Ray Roberts have maintained levels which are higher than many places within Texas which allows us to have minimal restrictions. However, if the predictions are accurate, everybody in North Texas should expect much stricter water restrictions in the future.

District 1-A would like to thank everybody who made a conscious effort this summer to restrict your water use. Because of your help, we have been able to provide the required water to each customer without having to increase water subscription levels which ultimately cost everybody.

FY 2011/12 ANNUAL BUDGET

As the result of a series of meetings of all Castle Hill's District's in August and September, District 1-A has adopted a fiscal year operating budget which reflects a 0.1% overall increase (\$9,410). The total combined budget for operations, maintenance, and administration of Castle Hill's has remained constant, for the second year, at \$9.7 million. The cost per connection over a 4-year cycle has been reduced from \$4,085 to \$3,704 or 9.33%. District 1-A continuously looks for ways to provide the highest level of service at an affordable price. When you shop, choose a Castle Hills retailer <u>first</u>. Through an agreement with the City of Lewisville, retailers in Castle Hills charge the 1.25% Lewisville municipal sales tax rate. Those tax dollars collected by the retailers are used to cover the expense of providing public safety services to the District, reducing the need to cover those expenses through property taxes or utility revenues. Funds in excess of the public safety expense are shared by the City of Lewisville and the Districts offsetting District debt obligations or as a new revenue source.

- There were 22 new homes permitted August.
- Customers purchased 96.2 million gallons of water in August, 2011, an increase of 3.5 million gallons from August, 2010. That represents an average decrease of 3,593 gallons per connection for August of this year compared to last year. Please help conservation water.
