

ORDER ESTABLISHING PUBLIC COMMENT POLICY

The Board of Directors of Denton County Fresh Water Supply District No. 1-C met in special session, open to the public, after due notice, at its regular meeting place outside the District, on the date hereinafter set out; whereupon the roll was called of the members of the Board of Directors ("Board"), to-wit:

All members of the Board were present except DIRECTOR BROWN

WHEREUPON, among other business conducted by the Board, Director HERMESMEYER introduced the Order set out below and moved its adoption, which motion was seconded by Director CASKEY, and after a full discussion and the question being put to the Board of Directors, said motion was carried by the following vote:

"Aye" 4; "No" 0.

The Order this adopted is as follows:

WHEREAS, Denton County Fresh Water Supply District No 1-C (the "District") is a conservation and reclamation district operating under Chapters 49 and 51 of the Texas Water Code; and

WHEREAS, the Board deems it appropriate to establish rules and standards in compliance with the Texas Open Meetings Act, Chapter 551, Government Code to maintain an orderly public commentary on the Board agenda, while affording members of the public an opportunity to speak;

IT IS, THEREFORE, ORDERED BY THE BOARD OF DIRECTORS OF DENTON COUNTY FRESH WATER SUPPLY DISTRICT NO. 1-C THAT:

Section 1. Public Comment Policy.

(a) Members of the public appearing before the Board may speak at the designated time allocated for public comment on the District Board meeting agenda. Except as waived or

otherwise authorized by a vote of the Board, members of the public may not comment on any item that is not on the formal meeting agenda.

(b) Except as waived or otherwise authorized by a vote of the Board, in order to speak before the Board, members of the public are required to register before the call to order, using the form attached hereto.

(c) Except as waived or otherwise authorized by a vote of the Board, in order to expedite the flow of business and to provide all members of the public the opportunity to speak, the Board hereby imposes a three-minute limitation on each member of the public addressing the Board.

(d) Members of the public may provide comments or information in writing to the Board through correspondence addressed to the Board of Directors, c/o Winstead PC, Attn: Ross Martin, 2728 N. Harwood Street, Suite 500, Dallas, Texas 75201.

Section 2. Effective Date. This Order shall take effect immediately on the date set forth herein.

Section 3. Execution. The President or Vice President is authorized to execute and the Secretary or Assistant Secretary to attest this Order on behalf of the Board and District.
